JOB SUMMARY

The Registrar at the NMCH will work to ensure the delivery of world class in- and out- patient paediatric care. The areas of service will include: the paediatric and neonatal intensive care units, the dialysis unit, the paediatric wards consisting of patients from nephrology, cardiology and cardiothoracic surgery, neurosurgery and general surgery. Medical officers will be required to perform overtime as the facility provides 24-hr care. Other responsibilities may include teaching undergraduate students, involvement in departmental and university administration and research.

In accordance with the Vision, Mission, Values and strategic direction of NMCH, patient and staff safety is a priority and responsibility of all NMCH employees, as such the requirement to continuously improve quality and safety is inherent in all aspects of this position.
