Background

The Nelson Mandela Children's Fund (NMCF) is seeking proposals from qualified consultants or firms to support the refinement and implementation of its Monitoring, Evaluation, and Learning (MEL) systems in alignment with its new strategic direction. This six-month engagement will contribute to strengthening the Fund's ability to track progress, assess impact, and foster learning across its programmes.

Scope of Work

The selected consultant or firm will be expected to:

1. Review and refine the Fund's Theory of Change, ensuring alignment with the new strategy and programme goals.
2. Develop new indicator frameworks that are practical, measurable, and aligned with the revised Theory of Change.
3. Propose a structure for the Fund's monitoring functions, including:
 - a. Functional design of MEL roles and responsibilities.
 - b. Drafting of role profiles in collaboration with the HR Business Partner.

Deliverables

1. A revised Theory of Change document.
2. A comprehensive indicator framework with definitions, data sources, and frequency of measurement.
3. A proposed MEL structure with clearly defined roles and responsibilities.
4. Draft role profiles for MEL staff positions.
